


Sir/Madam,

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MD(Pharmacology) qualification for 02 seats in respect of students being trained at Kasturba Medical College, Mangalore under Manipal Academy of Higher Education, Manipal**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
