

### Sub: Aviator Program from Bio-Rad - 28.10.2021

With reference to the above subject and further to the discussions had with undersigned to conduct the Aviator Program at your esteemed institute. We Thank you for your Interest in our Aviator Program scheduled on 28.10.2021. Please find below a brief description about the same.



As medicine is getting more and more evidence-based, laboratory testing is becoming more important. A correct report requires proper quality assurance and quality control processes in place. Quality Control in the laboratory is a very important aspect of laboratory management. However, the curriculum during postgraduation mainly focuses on the theory of disease and testing. Despite being one most important aspects of practical application, exposure to Quality Control management takes a back seat. Most of the time it comprises "on-the-job training" and we learn as we do. And at times, it becomes too much to expect from a fresh postgraduate.

## Prabodhan - 27/10/2021

The program was organized by the Department of Biochemistry, KMC, Manipal, collaborating with the Bio-Rad Laboratories company.

The program seeks to improve the laboratory's quality process in preparation for the impending NABL external audit of the Clinical laboratory departments of Kasturba Hospital Laboratory Services-Manipal.

Guest Speakers: Dr. Anjali Singh and Mr. Manas Ranjan

Audience: HOD, Faculty, and technicians of the dept of biochemistry, other clinical laboratory departments HOD /QM/ Lab-Incharge.

The program started with two and half hours of interactive lecture on Quality Control in detail, including the importance of QC, handling of materials, analysis of QC data, RCA for QC violation, records to be maintained for the QC process.

Followed by Dr. Anjali and Mr. Manas Ranjan visited the clinical biochemistry laboratory, did a mock audit (IQC/EQAS/ILC and other aspects of the lab), and gave a detailed review of our work. They provided an idea/solution to queries in the laboratory workflow. Feedback from the faculty regarding the program was much satisfactory and found to be beneficial. Dr. Anjali Singh will do a review of the audit in the future.

#### Aviator - 28/10/2021

The educational program on "Quality Control" sought to improve PG students' understanding of quality control and related troubleshooting, which will play a significant role in placement after completing the PG course.

The biochemistry department, KMC-Manipal, was organized with the audience of final year MD PG students of all clinical laboratory departments for a whole day (9 am-4:30 pm).
