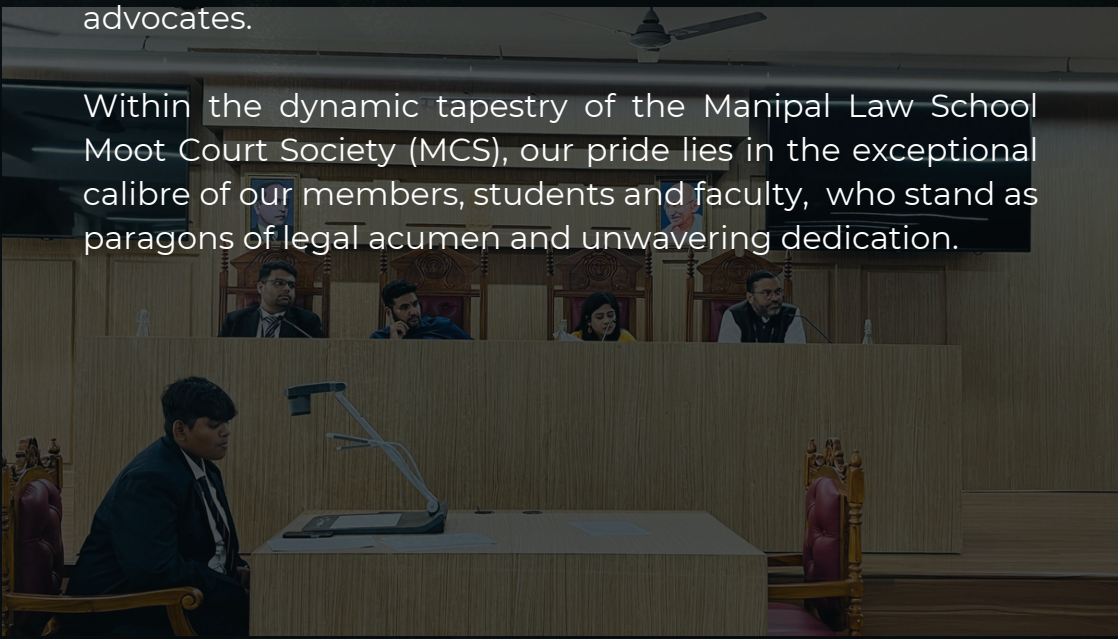
# MANIPAL LAW SCHOOL'S **MOOT COURT SOCIETY**

This year's theme puts things in perspective by raising questions about law's ability to govern technological advancements. With the stakes being that of one's right to privacy in an increasingly globalised world, further aggravated by the involvement of Artificial Intelligence, the participants will be expected to engage with the law critically and offer solutions to a particular kind of problem AI poses in the realm of human rights- Technology Facilitated Gender Based Violence.

## Tackling Tech-Facilitated Gender Based Violence

The rapid advancement of Artificial Intelligence (AI), digital platforms, and data-driven technologies has reshaped global governance frameworks, raising critical questions of liability, privacy, digital rights, and online safety. As societies become increasingly dependent on technology, emerging legal disputes highlight the complex interplay between innovation, national security, and fundamental rights—particularly in the context of technology-facilitated gender-based violence (TFGBV).



One of the central debates revolves around the liability of AI developers and digital intermediaries when their platforms are misused for generating deepfakes, enabling non-consensual content circulation, or facilitating online harassment. The legal framework governing traceability, intermediary protections, and AI transparency remains a gray area, requiring courts and policymakers to interpret evolving laws in light of online gender-based harm and the duty of platforms to ensure digital safety. Another key issue concerns the role of governments in regulating AI and digital platforms, particularly through bans, compliance mandates, and security regulations that may clash with business interests, freedom of expression, and global trade laws, but are often justified as safeguards against online exploitation and digital abuse.

Furthermore, the proposition raises critical concerns over data privacy, content authenticity, and digital platform accountability, questioning the extent to which platforms must proactively prevent the misuse of AI-generated content while preserving user autonomy and innovation. As courts grapple with these issues, the legal community must explore nuanced, technology-specific regulatory frameworks that address TFGbV, AI misuse, and intermediary responsibility, while setting global precedents for AI governance, platform liability, and digital rights protection in the evolving digital era.

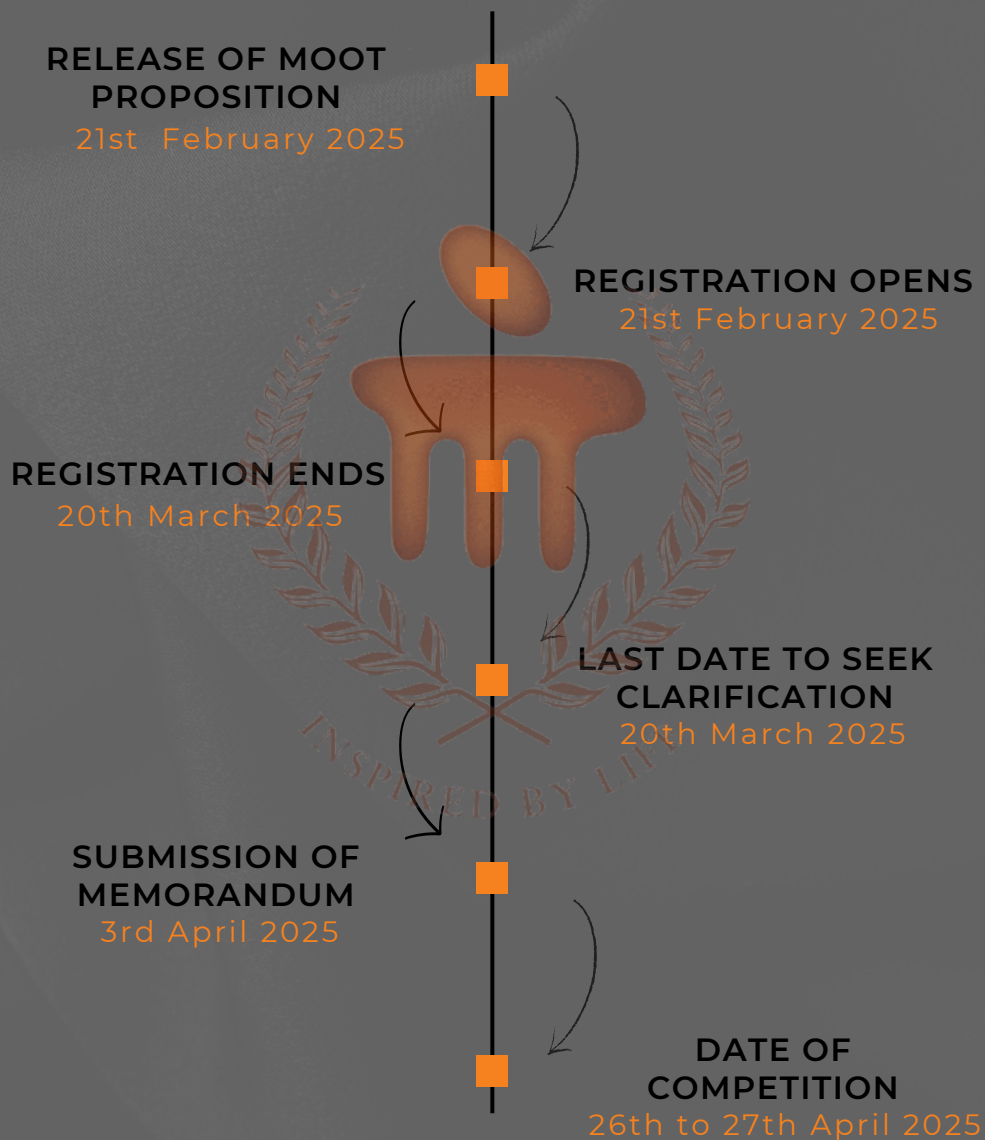
